  - Taylor and Francis has 3,000 institutional subscribers

The Bylaws require that this vacancy be filled in order to maintain the required number of board members. Also, he was Vice President slated to step into the presidency for 2019-2020. ## **Old Business**

1. Changes to way president is elected – A suggestion was made by Mark Mitchell at the 2018 business meeting that the PAS consider changing the way the president is elected. It was suggested that other organizations have a system in which the president serves a two-year term and is elected directly by the membership. Mike

Fosha undertook the task of looking into this and the Board discussed the following proposal.

The position of PAS President will be changed to a two-year term and the position will be directly elected by the PAS Membership, rather than by board members.

- President would come on to the Board as President Elect and serve a two-year term as President (this would fulfill their three-year Board term).
- The position of Past-President would be eliminated as the President Elect would be mentored by the current President.
- There would only be a Presidential election every other year.
- President would become an additional board position. Every other year there would be an extra nominee running specifically to be President Elect that will be voted on by the full PAS membership.
- This proposal would expand the Board to 10 members which will also require a Bylaws change. The Bylaws also indicate that a quorum for a board meeting is half which could result in a split vote if there are 10 members.

Discussion:

- a. If no one will step forward to serve a two-year term as president we will revert to finding someone within the existing board.
- b. Does past president position still exist? No there will always be overlap with president and president elect. But a past president will be unofficially available to offer advice.
- c. If we pursue this Bylaws changes will be necessary.
  - i. Bylaws will have to remove the Past President and redefine the Vice President positions;
  - ii. Will have to specify that the PAS membership will elect president as a new, 10<sup>th</sup>, member of the board;
  - iii. Will need to specify that the president will serve a two-year term.
  - iv. Issues of quorum and possible voting ties also need to be addressed.
  - v. It will also be necessary to make changes that will address the possibility of a gap during the period transitioning between the two systems.
- d. Bob Hoard offered to research and propose necessary bylaws changes to put before the PAS membership.

Motion made by Jay Sturdevant to table this discussion until the Bylaws changes are spelled out and presented to the membership.

Motion seconded

Passed unanimously

2. Web Site – The new web site is up and running. Thanks are due to Courtney Ziska and Chris Johnston for all their hard work.

## **New Business**

1. Harassment policy – Adair read the new policy on Sexual Harassment and Anti-Discrimination.

*The Plains Anthropological Society (PAS) is committed to providing a safe and collegial space for all of our members regardless of age, ethnicity, race, gender identity or expression, sexual orientation, disabilities, religion, marital status, or for reasons unrelated to professional performance. All members of the PAS deserve courtesy and respect in an environment where one can converse, interact, learn, and grow. The PAS does not tolerate harassment, assault, bullying, or intimidation. As an organization, the PAS is committed to ensuring the safety, well-being, and inclusion of all our members and guests at PAS-sponsored functions.*

She explained that it will be necessary for individuals to agree to this policy to become a member or renew membership. It will also be necessary for members and their guests to agree to follow the policy when registering for conferences.

2. The Board has voted to increase treasurer's stipend from \$2000 to \$7000
3. Forthcoming conferences:
  - a. 2020 Boulder, CO. – Doug Bamforth announce the conference scheduled for November 4-7<sup>th</sup> in Boulder, CO. It will be held at the Embassy suites and Hilton Garden Inn. Both offer breakfast and have easy access to airport. Collaborators include: a reception at the Colorado University Museum. A craft beer exposition. Wednesday tours Magic Mountain, Lamb Springs, and the Denver Museum.
    - If you are bringing children, please register them so they can get name tags and be recognized as being associated with the conference. There will be no additional charge for children.
    - There will be no registration charge to students who are presenting papers.
  - b. 2021 – South Dakota State Historical Society proposes to host the 2021 Conference
    - David Williams proposed for mid-October
    - SDSHS proposal includes \$89/night rate at the hotel Rapid City
    - Possible tours – Deadwood Walking tour, Southern Black Hills Rock Art

- c. 2022 – Oklahoma University proposes to host the 2022 conference in Oklahoma City (not Norman)

- They would rent entire hotel for conference
- Possible tours include the Wichita Heritage and History Tour and Panhandle Bison Kill Sites tour
