Board of Directors First Meeting

79th Plains Anthropological Conference 12 October 2022, 6:00 CT

- 1. Welcome and Call to Order
 - a. Called to order at 6:39pm CT
- 2. Approval of the Agenda
 - a. Agenda approved, but did not catch motion or second
- 3. Conference Organizers' Remarks (Brandi Bethke and Sarah Trabert)
 - a. Year long campaign for private donations
 - i.Most money from Thursday night networking event. Had local CRM companies pay \$1,000 a table.
 - ii.Beer donated from local distributor.
 - iii.ODOT and the University of Oklahoma (Anthropology and Geology) donated a bunch of money.
 - iv. Total raised around \$60,000 and total cost of conference around \$50,000. Preliminary profit estimate of around \$7,000 from this conference, taking into account PAS startup costs.
 - v.Currently, Bethke and Trabert's department covering Thursday catering bill because of tax exempt status. May ask for PAS to cover costs because of good profit. PAS will still make over \$4,000 on conference if they cover that cost.
 - b. Have already made over \$1,000 in on-site registration as of this Board meeting.
 - c. As of October 9th, registration includes 152 regular members, 133 students (57 of which from OU), and 26 tribal members.
 - i.A lot of OU students wouldn't have come if registration wasn't free (mostly undergrads). They tried to engage students by giving talks in classes and having professors make students come.
 - ii.Same with tribal members. Organizers sent letters to THPO offices and colleges announcing conference. There are 39 tribal entities in Oklahoma.
 - d. Discussion about number of regular registrants being down.
 - i.Hollenback suggested it's because post-covid people were disengaged.
 - ii. Trabert offered Lincoln as example of big conference.
 - iii.Conference attendees not as much a concern as low numbers of presentations (80 submitted).
 - iv. Billeck noted that low presentations correspond with low articles.
- 4. Student Paper Award Committee Report (Hollenback)
 - a. We had 7 students in competition, an increase from last year. All student paper applicants are graduate students.

- b.2 papers were submitted late this year, so Board needs to figure out if those get disqualified. 2 papers are multi-author, and Board needs to decide if these should be considered as well.
- c. Discussion on multi-authored papers and late papers
 - i.Hollenback argues that archaeology is becoming multi-disciplinary. Hard science papers often have multiple authors. However, we should probably omit late papers from consideration.
 - ii.Billeck proposal is to incorporate a clear listing of roles for multi-authored papers or posters
 - iii.Pelton said that sticking to current award specifications as listed is probably best course for this year
 - iv. We decided not to consider multi-author papers not late papers this year because it is in the specifications of the award. We will consider multiple author issue next year.
- d.Discussion on increasing award amount
 - i.Someone (not noted) suggested that we increase the student paper award amounts ii.Johnston moved to raise award amount by \$100 for all student awards starting this year (Bethke second). Unanimously approved.
- e. Further discussion
 - i Hadley suggested removing undergrad presentation in favor of poster. Johnston suggested keeping it because we don't always award undergrads if paper is good.
 - ii.Board is counting on Hollenback to do student paper award again next year.
- 5. Webmaster and Website Report (Ziska)
 - a. Most people using website for journal access and membership renewal.
 - b. Ziska is resigning as webmaster
 - i. Has been managing mass mailers for Plains in addition to webmaster duties
 - ii. Website troubleshooting is really time consuming, which is likely a hosting issue.
 - c. Pelton asked if website is free
 - i. No, at least \$2500 a year for hosting, maintenance, etc.
 - d. We discussed options to streamline website.
 - i. Pelton suggested stripping website down to core functions and documents. Maybe moving registration and membership renewal to Squarespace.
 - ii. An issue is the membership credentials that our current website facilitates. Hard to move those over. Johnston says that maybe doing both, building conference website on easier platform.
 - iii. Johnston and Ziska will sit down and discuss alternatives to website hosting over next couple of months.
 - e. Other website issues
 - i. Hadley asked about member/non-member fees for conference registration. The website doesn't discriminate, but abstract submission does rely on credentials.
 - ii. Ziska mentioned that dual-factor authentication goes to her phone, so others have trouble signing into gmail/mailchimp. Best solution is probably just remove authentication.
 - iii. Ziska says we should also consider digital archiving.
- 6. Approval of Summer Board Meeting Minutes (5 May 2022)
 - a. Hedden motions to approve, Johnston second. Unanimous approval.

7. Officers' Reports

- a. President's Report (Pool)
 - i. This year seemed easy! Doing good job at meeting PAS goals. Financials are good. Students very engaged and we're giving them a lot of money.
 - ii. Glitches: Has student affairs committee run its course? Carlton had to coerce people to join this year. People just don't know what to do.
 - 1. Hadley wanted to know if the head of the SAC is on Board and was told that they went to Board meetings until recently but were not on Board.
 - 2. There is a liaison position on Board.
 - 3. Last year, Board made a motion to give \$500 to SAC to support lunch, but this year conference organizers provided funds.
 - iii. No ongoing ethics or inclusion complaints, developing codes of conduct, self certification, etc. Bethke used self certification to ensure that spouses or SO's registered for conference as well.
 - iv. One issue is that we are not getting enough submissions for Plains.
 - 1. Discussion on why we're not getting more submissions. Maybe post-covid. Other options are crowded publication field (e.g., the various spinoff journal 'reports').
- a. Treasurer and PAS Endowment Committee Reports (Johnston)
 - a. PAS finances are great.
 - i. 2021 Boulder conference made \$7,000 and the City of Boulder wrote a check for \$2,000. We made a total of \$9,000 on conference.
 - ii. Investment accounts are not great because markets in general are poor. PAS endowment started at \$100,000, got to \$138,000 at peak, and is now at \$110,000. Roper account has lost money on investment but we've also pulled some money out for awards.
 - b. Billeck asked if we would be alright if we didn't have meetings. Johnston says we'd be revenue neutral without them. Johnston sees that attendance is down in general.
 - c. Hedden moved to accept Treasurer's report, Hadley second. Unanimous approval.
- 8. Committee Reports, new or follow-up discussions from Pre-meeting (4 October 2022)
 - a. Archives (Pelton)
 - i. Pelton was asked if archivist needed help setting up new sub-series. Pelton said that everything is in Board handbook, so no need to duplicate committee reports when we can just submit the handbook.
 - ii. Pelton will begin submitting handbook to archives in addition to conference program.
 - b. Bylaws (Hedden/Pool)
 - i. see handout for 1 or 2 nominee scenarios for Business Meeting
 - ii. It's complicated, so Pool and Hedden will tag team at business meeting.
 - c. Membership (Hadley)
 - i. note updates since Pre-Meeting
 - ii. Membership back to pre-covid levels
 - a. Native American Student Award (Meyers)
 - a. Had 5 nominees. Hadley suggesting that each get \$500, pending approval of extra \$500.

- b. Discussion on how to allocate award funds with multiple applicants
 - i. Gover was only one to win when he applied. Wants people to feel good when they win rather than feel like they got a handout.
 - ii. Hadley clarified that it's a scholarship, not an award.
 - iii. Discussion on original intent, which was to engage more Plains tribal members with organization.
 - iv. If we impose a rubric, then it should probably be need-based.
 - v. Gover said he would take on duties on NASA committee
- c. Johnston moved to allocate \$3,000 to award this year (Hedden second), motion passes.
- b. Resolutions (Wiewel)—note updates since Pre-Meeting
- c. Financial Review (Johnston, for Mitchell)
 - a. We're in sound financial standing
- d. Undergraduate Student Travel Grant Award (Arendt)
 - a. Discussion of continuation of award
 - i. Johnston most comfortable doing this on an annual basis rather than taking money out of endowment now. \$5,000 a good number annually.
 - b. Arendt moves to continue on annual basis at \$5k, Johnston second. Unanimous.

9. Old Business

- a. MAC's Sensitive Image Policy (Hedden)
 - i. Summary of policy
 - 1. Won't publish images of human bones anymore, but can use line drawings.
 - 2. Pathologies shown as small area.
 - 3. Suggest we form our own committee to figure out which aspects we want to accept or add to and run it by membership and Tribes.
 - ii. Johnston moves to form ad hoc committee to determine sensitive image policy (Billeck second), unanimous approval.
- b. TDAR hosting conference abstracts (Kelly)
 - i. Provided brief update on conversations with Director, but not specifics.
