Plains Anthropological Society Pre-Conference Board Meeting via Zoom Tuesday, October 4th, 2022 Minutes

- 1. Welcome and announcements
 - a. Called to order by President Kelly Pool at 8:37 am
- 2. Approval of Agenda
 - a. Hedden motion to approve, Billeck second, unanimously approved
- 3. Introduction of new Board Members
 - a. Veronica Mraz is in Iowa and works for State
 - b. Cody Newton in Wyoming working for SWCA
- 4. Brief conference update (Bethke)
 - a. Have everything in place. Going today for final walkthrough. Have enough money to pay bills. Close to 300 people registered, around half of which students. Around 200 people signed up for networking event.
- 5. Officer's Reports
 - a. President
 - i. Will give at meeting
 - b. Treasurer and Endowment Committee
 - i. Will give at meeting
 - c. Editor
 - i. Presently on volume 67
 - ii. 2 issues have been printed and distributed. 3rd issue submitted and awaiting mailing to membership.
 - iii. Has 1 article in hand for November and 1 submitted (but initial reviews not good).
 - iv. Average years published 14 articles and reports. This year we've gotten 7 submitted articles. Need more submissions. 3 articles in a group and a fourth article pending. Promise of a memoir. But if submissions continue at this rate, Plains is in trouble.
 - v. Press used to have a page quota, but thinking about switching it to complete article quota (14 to 17 a year).
 - vi. Biden Admin says that Federally-funded research has to be open access. Press requires fee for open access. Questions over what this means. Is every CRM project Federally-funded?
 - vii. Bubel confirmed that submissions are down for the journal she edits as well. Also noted that Canadian funding sources require open access already. Noted that winner of student paper competition is encouraged to publish.

f. Membership

- i. Total of 444 current members, up from last year but not much. 323 individual members, 72 student members (up from 47 in 2021), 32 lifetime members, 17 secondary members on joint accounts.
- ii. Most of job was answering emails about password resets. 1 or 2 emails a week, more inquiries closer to conference.
- iii. Biggest membership states are: Colorado (56), Oklahoma (60), Texas (40), and Wyoming (40).
- iv. Making website more accessible for future membership committee is a priority (i.e., ability to remove members)

g. NASA

- i. Had 5 applicants this year. Have had 1 or 2 people in past. Never had this many applicants. Applicants from all across county (Augustana, OU, Kansas State, UCLA, CU Boulder).
- ii. Brandi sent letters out to all local colleges and THPOs, but most of the folks seem to have been influenced by their advisor.
- iii. Chris suggested holding off discussion of how many award to disburse until we're in person
- iv. Have allocated 2,000 on an annual basis to NASA
- v. Don Wyckoff has donated \$500 from book royalties to this as well
- vi. Chase Earl donated a piece of art to auction for this award

h. Nominations

i. Didn't have a ton of people who were contacted and not interested. Initially 7 candidates and only 1 backed out. Didn't have a single recommendation from general membership. Had 114 people vote (similar to recent years). Voting down 25% from 5 years ago.

- ii. Suggested providing a nomination form to incentivize nominations from membership.
- iii. Can we do this because we need 2 members to nominate people? Nominating chair can handle getting a 'second'.
